HBU Peer-Mentoring Program

- Designed to help foster relationships among community coalition partners with national & federal partners, improve skills and enhance the sharing of best practices across the HBU coalition
- Mentors- volunteers from HBU community partners that have extensive experience conducting Hep B programs
- Groups that express interest (mentees) will sign up for the program and inform HBF of their specific technical assistance needs

Peer Mentoring Program Activities

- Program participants complete orientation/training to discuss goals
- Mentor will complete site visit to assess needs and develop a one-year strategic plan in alignment with HBU goals
- Mentee will complete one site visit to mentor to observe programing (World Hepatitis Day, May Hep Awareness Month)
- Quarterly submissions to HBF on reporting
- Participants will have ongoing communication do discuss progress

Hepatitis B Foundation is offering mini-grants for one year to HBU partners working on hepatitis B screening, education and linkage to care



Up to 7 awards will be given ranging from \$5,000 to 10,000 each

Mini-Grant RFP

Eligibility

Applicants should be able to demonstrate that they have a in place an active, local coalition focusing on hepatitis B education, screening and linkage to care activities. 02

Eligible applicants must be current HBU members with the capacity to directly implement the proposal, collect data as required, provide written reports, and manage the funds appropriately. 03

Applicants must submit a project proposal (see RFP for details) Enhance the capacity of HBU coalition partners to conduct HBV education, screening and linkage to care in their local communities with focus on Asian American, Native Hawaiian and Pacific Islander communities, and supporting activities at the local coalition level to advance the hepatitis B priority areas of the U.S. Department of Health and Human Services' National Viral Hepatitis Action Plan.

 - 1: Prevention and Education
 - 2: Linkage to Care
 - 3: Surveillance
